It is further **EXPRESSLY** agreed that all use by the undersigned of such school facilities and equipment shall be undertaken at the undersigned's sole risk and that the school shall not be liable for any claims, demands, injuries, damages, actions, or causes of action, and from all acts of active or passive negligence on the part of the school, its agents, servants, or employees.
- 11. The rental fee is to be paid in full on an annual basis.
- 12. Your rental key is only for your access and no one else. Any entrance by others with your key will result in loss of use of the facility and there will be no rental fee reimbursement returned to you.
- 13. The weight room entrance and lifting area has video surveillance.
- 14. Report any known misuse of the facility to the administration.
- 15. If you are under the age of 18 your parent must accompany you while in the building.
